- To organize programs for awareness of the masses on the issue of public and country interest.

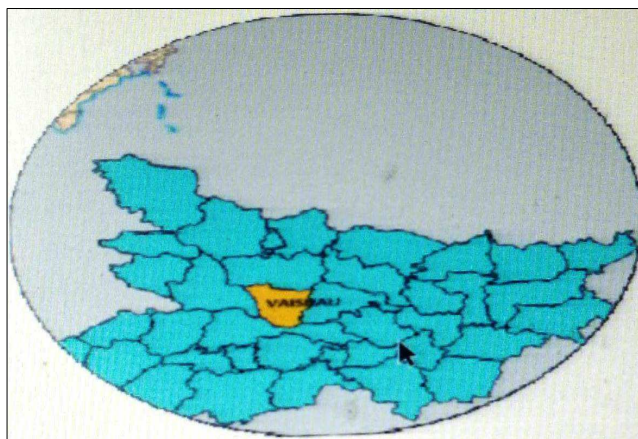
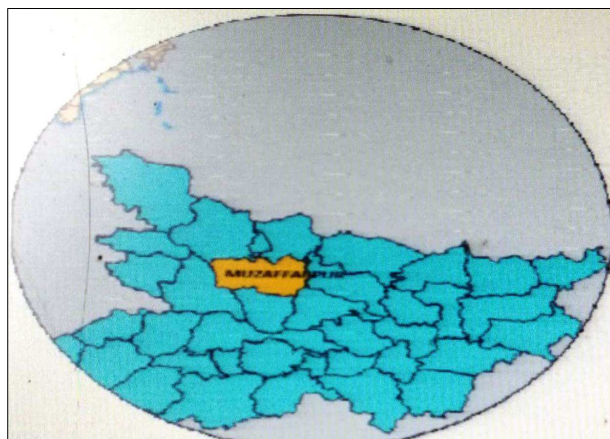

## ACTIVITY/PROGRAM DETAILS

### 1. COVID-19 RELIEF WORK

India's lockdown for curbing COVID-19 has hurt the daily wage earners and poor underprivileged families severely. They have lost their income. Poverty had prevented them from saving any money, they are now unable to buy food. They are starving.

During these challenging and uncertain times, ASS supported poor and vulnerable communities in different blocks of Muzaffarpur district in Bihar especially reaching out to migrants, rickshaw pullers, disabled, and women facing acute hunger and starvation because of no work- no income situation.

In 2020-21, ASS helped 1014 poor families of 4 blocks- Marwan, Musahari, Minapur, and Kurhani blocks of Muzaffarpur district in Bihar supported by PPI, USA, SAMA, New Delhi, and by Robert and Ghislaine af Sandeberg a devoted couple of USA and Dr. Arun Shah, USA. Foods and essentials preventive items like rice, pulses, potatoes, oil, salt, biscuits, masks, sanitary pads, and soaps were distributed for ensuring poor people's survival.

The block-wise details of the distribution work are as follows:

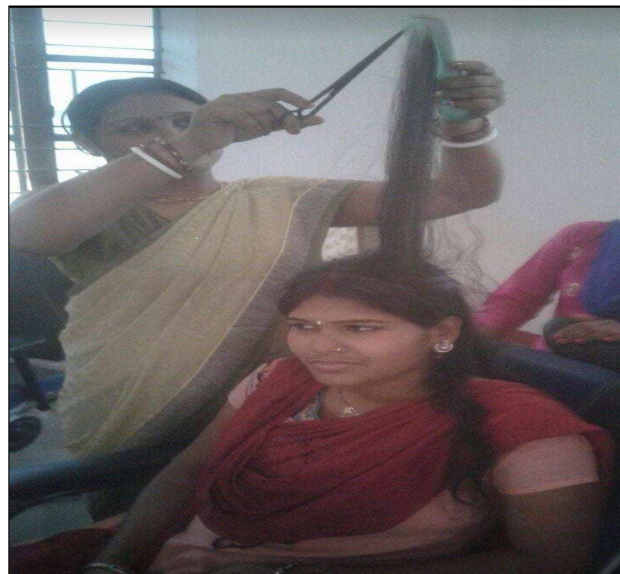

## 2. VOCATIONAL TRAINING PROGRAM

With the financial support of Robert and Ghislaine af' Sandeberg, a devoted couple of USA, ASS organized 2 batches of training (25 women and girls/batch) in tailoring and beautician trades for 50 girls and women of the poor SC and OBC classes who are unable to make progress because of the poverty and income generation opportunities. The training was organized at ASS office at Muzaffarpur and the beneficiaries were covered from Kurhani, Musahari, Marwan, Sakra, and Turki blocks of the Muzaffarpur district in Bihar. After getting skilled all of them are earning well and leading a good life.



### Measures Implemented

- ◆ Vocational training classes were conducted in Muzaffarpur.
- ◆ Rekha Kumari- Instructor recruited for tailoring training.
- ◆ Premshila Devi- Instructor recruited for beautician training.
- ◆ Regular classes are conducted for quality skill generation among women and girls.

## 3. BIO SAND WATER FILTER PROGRAM

Every year, nearly 6,00,000 children die in India due to illnesses associated with unclean drinking water. Inspire of this, 2 out of every 3 households still do not treat their drinking water and half of the rural water supply, where 70% of India's population lives, is routinely contaminated with toxic bacteria. In the villages of Bihar, people are not aware of the dangers of contaminated water and also do not have the means of convenience to obtain potable water. Bio Sand is a simple water filter method that uses sand, gravel, and living microorganisms to clean water. A compact, concrete, or plastic body is filled with layers of prepared sand and gravel. These layers remove the pathogens and suspended solids from the contaminated drinking water. At the top 2 cm of the sand layer, is the biolayer, which is simply a colony of bacteria and microorganisms that gobble up most of the pathogens in the water.



In 2020-21, ASS with the financial support of PPI, USA addressed safe drinking water issues in the villages of the Marwan and Musahari blocks in Muzaffarpur district in Bihar.



The project activities were organized by ASS under the shadow of COVID-19 with ongoing restrictions by the Govt. of Bihar as safety norms for the people from COVID-19. However, ASS organized BSF project activities regularly in the lines of COVID-19 guidelines of the Government. During the year following activities were organized:

(a) **Awareness Generation**: 2 awareness programs were organized. On 23.02.2021, it was organized at Kesho village and on 08.03.2021 at the office premises of ASS. Women, young girls, and village communities were highly benefited from the program. In these awareness programs following important matters were discussed:

- How does BSF function?
- General health, young girl health, and how unsafe drinking water affects health especially women's health.
- BSF is very easy to maintain and it is non-expensive and problem-free.
- People were encouraged to drink BSF water regularly.



(b) **Construction and Distribution of BSF**: 62 BSFs were constructed and distributed in the poor people's homes at Minapur block with the education of users for keeping the filters maintained and works for replication.



#### 4. **MERI PANCHYAT MERI SHAKTI PROGRAM**

Under Meri Panchayat Meri Shakti (MPMS) program, ASS is working since January 2018 covering 10 Panchayats and 3 blocks namely Marwan, Kurhani, and Musahari of Muzaffarpur district in Bihar benefitting Elected Women Representatives (EWRs) of the Panchayati Raj Institutions and SHGs.

Under the program, EWRs and SHGs are regularly sensitized on issues that affect the wellbeing of women and girls in the Panchayat such as Gender-Based Violence. Further, they are given the skills and support to raise these issues in the Panchayats for positive



transformations. Under the vision of Feminist Leadership building, this MPMS program also enhancing the leadership potentials and skills of village women leaders (EWRs and SHGs) and building a positive ecosystem for women and girls.

### Measures Implemented

- Issues of general health, gender, women leadership, and RH were discussed.
- Regular meetings organized with Panchayat stakeholders at the PHCs and Anganwadi Kendra that took them to a new journey of self-reflection and to explore their strengths, talk about their struggles and come out with concrete plans to achieve their dreams and aspirations.
- Meetings were organized with the EWRs families for giving them more freedom to work for bringing changes in the low status of women in the family and society as well.



### 5. Workshops, Seminars and Camps

ASS believes that information dissemination is crucial for the progress of society. In 2019-20, several workshops, seminars, and camps were organized by ASS in Muzaffarpur and Vaishali districts in Bihar covering different issues/topics of socio-economic importance. Experience resource persons and eminent personalities were invited on these occasions to share their views and knowledge with the participants. The details are as follows-

Important events like National Day & Bihar Celebration, Gandhi Jayanti, L.B. Shastri Jayanti, J. P. Jayanti, Teachers Day, etc. were also celebrated by ASS with great



enthusiasm and larger community participation in Muzaffarpur and Vaishali districts in Bihar.

## 6. **16 Days Activism (Campaigning) Program**

Violence towards women is a community problem. Everyone in the community, from schools to sporting clubs, can play a role in changing the structures, norms, and practices that lead to gender-based violence. Some of these actions will be individual and some will be collective: gender-based violence is a structural issue that we all need to work together to address.

Supported by CREA- ASS organized a “16 Days Activism (Campaigning)” from 25-11-2020 to 10-12-2020 at Marwan, Kurhani, and Musahari blocks of Muzaffarpur district in Bihar covering 10 Panchayats overall to end violence and gender-based discrimination against all women, girls, and transgender people. The main objective of the program was- **“NAZRIYA BADLO”, “Know – Desire, Recognise – Vividhata and Understand – Concern”**. A total of **218** adolescent girls and **118** transgender participated in this campaign to make it a success.



## 7. **AWARENESS, MEETINGS AND RALLY ON POSCO ACT**

To effectively address the heinous crimes of sexual abuse and sexual exploitation of children through less ambiguous and more stringent legal provisions, the Ministry of Women and Child Development championed the introduction of the Protection of Children from Sexual Offences (POCSO) Act, 2012. The Act has been enacted to protect children from offenses of sexual assault, sexual harassment, etc., and provide for the establishment of Special Courts for the trial of such offenses and related matters and incidents. The Act was amended in 2019, to make provisions for enhancement of punishments for various offenses to deter the perpetrators and ensure safety, security, and dignified childhood for a child.

In 2020-21, ASS with the support of World Vision India, Muzaffarpur had organized the following programs:

(i) **POSCO ACT Zoom Meeting with Children:** Children who have been sexually abused are not only traumatized as a result of their experience but are also more vulnerable to further and repeated abuse and at risk of secondary victimization at the hands of the justice delivery process. A common example is the handling of cases of child victims by unspecialized police, prosecutors, and judges who have not trained injustice for children, children’s rights, or how to deal and communicate with victim children and their families.

To discuss the POSCO Act and make adolescent girls familiar with different provisions of the Act, Zoom Meetings were organized on 4-12-2020 by ASS in which 102 adolescent girls participated.

(ii) **Children's Rally:** (a) Children's rallies on child sexual abuse were organized in 18 villages of Marwan block in Muzaffarpur district in Bihar in which children below 18 years participated. These rallies were organized following the standard practices of COVID-19. These rallies helped in sensitizing PRI representatives on their roles and responsibilities in child sexual protection and the promotion of child rights. Awareness was also promoted on CHILDLINE 1098 service for services to children in need of aid and assistance in India.



(b) A Rally was also organized on the issue of "Child Protection Rights" in Rupwara Panchayat of the Marwan block in Muzaffarpur district. 40 children participated in this rally with success.

(iii) **Meeting on POSCO Act:** On 17.12.2020 an awareness meeting on POSCO Act was organized at Block Office, Marwan in which 39 people participated. The meeting highlighted different provisions of the POSCO Act and the formation of the CPCs. It was urged by BDO to initiate the process of CPC in all wards and Panchayats of Marwan block so that the children will be protected and become safe.
